Terms and Condition for Household Goods and Personal Effects

Property covered: Household goods and personal effects, antiques, fine arts, and automobiles as declared and valued on supporting documents.

Transit Clause: A. This insurance attaches from the time the goods leave the residence or warehouse for the commencement of the transit and continues until: (1) The goods are delivered to the consignee's residence or to the other final warehouse or place of storage at the destination named in the certificate or (2) The goods are delivered to any other warehouse or place of storage- whether prior to or at the destination named in the certificate which the insured elects to use either (a) for storage, other than the ordinary course of transit, or (b) for allocation or distribution, or (3) The expiry of 60 days of arrival in state or country of destination, whichever shall first occur. Extension of coverage is available at an additional premium beyond 60 days at origin or destination, if in protected commercial warehouses only. B. It is a condition of this insurance that there shall be no interruption or suspension of transit unless due to circumstances beyond of the insured and that the insured shall act with reasonable dispatch in all circumstances within their control. C. Goods insured must be packaged and delivered by qualified mover.

100% Co - insurance Clause: If the amount of insurance purchased is not equal to the replacement cost of the property at the time of insuring, the underwriters will not pay for actual full value of any item lost or damaged. The insured shall to the extent of such deficit bear his, her or their proportion of the loss. A household goods descriptive inventory must be prepared by the mover at origin showing the condition of the goods shipped. It is the duty of the insured/certificate holder to provide a valued inventory at the time of packing
